 Racism in the United States is a deeply intractable problem that negatively shapes all aspects of the world experienced by people of color and literally steals years from their lives. Black and Indigenous families and communities in the United States continue to be disproportionately incarcerated, systematically excluded from economic opportunity, and, in outcomes as diverse as preterm birth and COVID-19 death, bear a disparate proportion of disease and hardship.
