Many Hands received 133 grant applications between October 1 and November 5. We are grateful to all the organizations who took the time to tell us about their work. If you are interested in learning more about this year's grantmaking process and timeline, please visit our website.

The Grants Committee is currently reviewing all applications to ensure that they meet our eligibility criteria and are assigned to the appropriate Focus Area Committees (FACs). Following this review, the four FACs--Housing, Health, Education, and Economic Empowerment--will start meeting to discuss applications in depth.

Focus area work commences in January and culminates in May with the membership-wide vote that determines which organization will receive the Many Hands \$100,000 Impact Grant and which will receive Partner Grants, which have exceeded \$50,000 in recent

years.

The more than 50 Many Hands members who are participating in "Head, Heart, and Hands" have taken a deep dive into some of the fundamental questions driving our racial equity work: What are possible impacts of the differences between the nonprofit/philanthropic sector and the communities they seek to serve? What are some of the causes of disparities that persist within or may be perpetuated by philanthropy? What can funders like Many Hands do to

reduce these disparities?


Member Spotlight and Book Review: Say It Loud!

Longtime Many Hands member Shelley Stanfield has served on numerous FACs as well as the Racial Equity Working Group. We asked Shelley to share a little about herself and her connection to Many Hands.



Why did you join Many Hands? As a retired magazine reporter on various aspects of social policy, I was looking for a coordinated, rational way to focus my charitable giving. In 2012, my daughterin-law introduced me to Many Hands, and it has been a perfect fit. Which focus area attracts you most? Economic Empowerment attracted me because it is at the root of helping others. How do you stay inspired? I stay inspired because there is no alternative.

Shelley focuses much of her reading and thinking on racial equity, and a recent book she recommends is *Say It Loud! On Race, Law, History, and Culture* by Harvard Law School Professor Randall Kennedy. Despite the book's name, she says, Kennedy uses mostly measured language and carefully reasoned arguments to describe how "racism continues to be a major force in America," despite what he calls the inspirational



African American journey from slavery to freedom. In 29 essays, he discusses both the present situation--including "the George Floyd Moment"--and the landmark Supreme Court decisions that have shaped our racial history. But Kennedy doesn't mince words. A damning chapter on Justice Clarence Thomas, for example, describes Thomas's "vapidity and opportunism" and compares his legal rulings to "the platform of the Republican Party and the talking points of Rush Limbaugh."

COVID's Impact on Nonprofits

A new report from the Urban Institute highlights the challenges the pandemic has created for nonprofits. According to Nonprofit Trends and Impacts 2021, 40% of nonprofits saw revenues decline in 2020, with an average decrease of 31%.



Many organizations scaled back services between March 2020 and spring 2021, with 47% reporting that they reduced the number of people they served and 44% responding that they reduced the number of programs. Yet many others expanded as demand for services soared: 41% of nonprofits served more people, and 38% operated more programs during the pandemic. Nearly one-third of organizations reported serving a wider geographic area, compared to 10% that pulled back.

The report also examined nonprofit demographics and found that 79% of executive directors and board chairs are non-Hispanic white, exceeding their share of the nonprofit workforce by 11 percentage points. The percentage of boards that are entirely white has declined from 51% in 2005 to 30% today, but nearly one in six nonprofits serving primarily people of color have all white boards. Women, who make up two-thirds of the nonprofit workforce, serve as executive directors at 62% of organizations and as board chairs at under half.
