IS REVIEWED BY A FINANCIAL REVIEW COMMITTEE. AS LONG AS THERE IS NO NEED TO ELIMINATE ANY OF THE 12 ORGANIZATIONS BECAUSE OF FINANCIAL CONCERNS, IN MAY, EACH COMMITTEE SELECTS ONE NONPROFIT TO PRESENT TO MANY HANDS DONORS FOR A VOTE. ONE ORGANIZATION RECEIVES \$100,000, AND THE OTHER THREE FINALISTS RECEIVE EQUAL SHARES OF THE REMAINING GRANT MONEY.
